**Xi – Irritant; F – Flammable**

Acute & Chronic Hazards: May cause eye, respiratory and skin irritation. Material is not known to cause significant health problems.

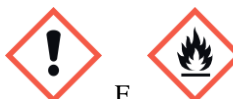
